

**A CITIZENS AMENDMENT  
TO ARTICLE 27 OF THE 1937 IRISH CONSTITUTION:**

**(IN REFERENCE TO THE SECOND AMENDMENT ACT, 1941)**

On the 30th May 1941, Section 2 in Article 27 of the 1937 Irish Constitution was deleted by the State (**OIREACHTAS PRESIDENT**) on behalf of the Sovereign Citizens of Ireland. **(WITHOUT THEIR PERMISSION).**

These words, **[SHALL BE IN WRITING SIGNED BY THE PETITIONERS]** were removed from Section 2, of Article 27, in 1941, from the 1937 Irish Constitution. To protect the States Natural Resources referred to in Article 10 of the 1937 Irish Constitution, e.g. OIL, GAS, WATER, FISHING, MINING, etc., from the Emerging Threat of Fascism, and communism in Europe at that time.

Nut today in 2015 these Natural Resources are still in Jeopardy, not only to European Interference, but to the Whim of the Irish State, because of the Second Amendment Act of 1941 which Omitted Legal Provision, **(a citizens signature referendum mechanism)** to Enable the Sovereign Citizens of Ireland to Deliberate on the Sale of these Assets by the Irish State, or any other Relevant Issue or Issues Deemed to be in the National Interest by the Sovereign Citizens of Ireland.

The Present Day Constitution was Enacted on the 1st of July 1937. The following is Section 2 of Article 27 in Full prior to the Second Amendment Act of 1941.

**[2. EVERY SUCH PETITION SHALL BE IN WRITING AND SHALL BE SIGNED BY THE PETITIONERS WHOSE SIGNATURES SHALL BE VERIFIED IN THE MANNER PRESCRIBED BY LAW].**

The Electorate Petitioned Mandate, Seeks a Citizens Mandate to Amend Article 27 by Reinstating Section 2 to the Present Day 1937 Irish Constitution. **(PLEASE SIGN THE PETITION AND RETURN TO), [A Citizens Amendment. 64 Oak Downs , Green Park, Clondalkin, Dublin 22].**

We would like to Assure Citizens that Great Care will be taken with their Signatures, and that these Petitions will not be Surrendered to any Bureaucrat. They will be Used to the Best of our Ability to Pursue Legal Action if Necessary , in the Amendment of Article 27. When this Objective is Attained, it is our Intention to put to the Sovereign Citizens of Ireland by form of National Referendum the following.

- 1/ Do you Wish to Nationalise Irish Water? Yes or No.
- 2/ Do you Approve of the Installation of Inferior Water Meters? Yes or No.
- 3/ Is the Corporate Entity that is Irish Water Acceptable to you, Do you Wish to see it Abolished? Yes or No.
- 4/ Do you Wish to Abolish the **(HSE)** the Health Service Executive in Favour of a More Progressive Fairer Health Service which you are Prepared to Fund and Hold to Account? Yes or No. Etc. Etc. Etc.
